#### Learning objectives

BRUNO INZITARI - ISTITUZIONI DI DIRITTO PRIVATO - MOD. A - (A-L) - 9 CFU - 72 ORE - I° SEMESTRE

The course has a double purpose:

- 1) Offering a general introduction to the study of Private Law and the basical elements about he actual Legal System as results from the Constitution, the Civil Code and also special legislation and jurisprudence;
- 2) Examining the specific themes of: persons, property, obligations and contracts, associations, protection of rights, assets and persons, claims and liability. Overall, the course focuses on all institutes of Private Law as discussed in handbooks.

BRUNO INZITARI - ISTITUZIONI DI DIRITTO PRIVATO - MOD. B (A-L) - 6 CFU - 48 ORE - II° SEMESTRE

The course focuses on the teaching of the institutes of Private Law and, in particular, family law, inheritance law and property law.

#### **Detailed program**

BRUNO INZITARI - ISTITUZIONI DI DIRITTO PRIVATO - MOD. A - (A-L) - 9 CFU - 72 ORE - I° SEMESTRE

The coursework includes: an introduction about the general notions of Legal System and Private Law; sources and applications of Private Law; legal relations and subjective situations. Legal facts and acts; subjects: persons and legal persons, associations, foundations and committees; obligations; general regulation of contracts and specific categories of contract; torts and liability; protection of rights (evidence, registration, prescription and forfeiture).

BRUNO INZITARI - ISTITUZIONI DI DIRITTO PRIVATO - MOD. B (A-L) - 6 CFU - 48 ORE - II° SEMESTRE

The coursework includes:

- regarding family law: kinship and affinity; marriage, filiation; parental authority; emancipation; affiliation and custody; disqualification and disablement; "amministrazione di sostegno", alimony;
- regarding inheritance law, legal succession and will, hereditary division and donations;
- regarding property law: regulation of goods, property, building lease, usufruct, use, right of residence, servitudes, communities, possession, "denuncia di nuova opera", "danno temuto".

#### **Prerequisites**

Good knowledge of written and spoken Italian, ability to analyze and reason

#### **Teaching methods**

Due to the amount of contests and their complexity and the importance to reach a complete knowledge of the subject, it is strongly recommended to attend frontal lessons, that will be organized in order to guarantee the treatise of the entire coursework and to allow, above all to freshers, to gain an effective understanding of the subject.
