## Learning objectives

The course aims at equipping students with theoretical instruments for analysis and argumentation useful to understand the different ethicallegal questions arising in the various bioethical fields. At the end of the course law students will be able to correctly elaborate legal reports, counselling etc. in bioethical issues

#### **Contents**
