Topics and course structure

The tuition course aims to introduce students to the general issues of education and pedagogy, paying particular with special reference to informal and social dimensions of education, and attention on: educational work - in terms of meaning, contents, contests of intervention and working methods - and on educators' professional figure.

Subject of the course 2019-20. Education between freedom and coercion

Pedagogical studies have always been characterized by two different assortments of educational meanings, aims and methodologies, sometimes in conflict, if not antagonists, some others synergical, if not integrated. In the most clear and distant representations, the first states the need for the individual to a full and free development of the own personality, education being at work for it. The second one, on the contrary, intends education as a process mainly aimed to the integration of individuals in the social context, even if this means to disadvantage them in the opportunities of freely express their individuality.

In every society, educational meanings and practices may have various combinations, leading to different – more or less stable – balances, depending on the economic and social assets, the cultural environment, the dominant ideologies. The core course aims to analyze these balances in contemporary society, with special reference to "general ideas" underlying educational projects and practices, as well as conflicting – explicit or hidden – dimensions, due to which it is difficult to make an adequately shared combination/synthesis of aims and objectives

of education.

The course includes a workshop (16 hours 2CFU).

Objectives

The educational intent consists in providing elements of knowledge through which stimulate abilities in carrying out a preliminary pedagogical analysis of educational experiences (professional and non-professional ones) in order to recognize their constituent elements, dynamics, involved subjects, social implications and criticisms.
