Course title

When literature deals with history

Topics and course structure

A critical approach to literary communication. In particular, the program deals with the main features of literariness and of narrative; the monographic section will focus on one or more patterns of narratives. This year the lecture course will focus on selected examples of narratives aiming to brief the reader on particular historical events. Historiographic works, as well as autobiographies or journals, are therefore excluded, in favor of chronicles or analysis of single moments or facts.

Objectives

The main goal is to assure that the students become familiar with the close reading of texts, that includes the ability to understand semantic values, ambiguities, implicit assumptions, and therefore to appreciate both communicative principles and cultural significance.

Methodologies

Lectures and discussion. Text analysis: linguistic and rhetorical features, narrative modes, cultural patterns. Summarizing Exercises
