Course title

Arabic Language II

Topics and course structure

Consolidation of linguistic skills at an elementary level. The course aims to develop listening and oral production skills in everyday situations and to start the student in reading and translating even non-vocalized texts.

Objectives

- 2) Capability to independently rework the grammatical structures and the words learned during the lessons.
- 3) Capability to formulate your opinion independently and to argue it effectively on simple subjects.

Tests during the year.

The final exam is divided in two parts:

1- a
written test of grammar, comprehension of the text and translation from Arabic into Italian and vice versa;

2- an
oral test of reading and conversation.

Both parts (written and oral) must be carried out during the same exam session. The student can refuse the final mark of the exam, not only the written or oral vote. In the event that the student refuses the final grade, he will have to take all the tests again. Students must register for both the written and oral exam.

At the end of the first semester an intermediate test will be carried out to verify the knowledge acquired in the first semester.
