# Principi e Fondamenti del Servizio Sociale

### Learning objectives

The course introduces the analysis of social work as academic discipline and as a profession. It describes its historical-philosophical-sociological underpinning, the system of values, the ethical-operative principles, and the theoretical orientations that constitute the foundation of social work scientific approach.

Upon completion of this course, students will be able to:

Articulate (in oral and written form) thoughts, ideas, and professional actions as key competencies for a social worker

#### **Detailed program**

The course is divided into two modules:

The first module deals with the theme of social work identity by analyzing national and international definitions as result of the evolution of social work from the origins to its development in the Italian social-political context. The social profession and professions (knowledge workers): definition, attributes, end professional identity construction.

Social worker profession: functions and activities articulated following trifocal approach, focused at the same time on institutional, social and professional mandates. Illustrate theoretical basis of social work, and describe a few reference models, beside the methodological process employed in social work

The second module analyzes the deontological codes focusing on functions, aims, structure, and specific contents. By making connections with actual activities of social workers, ethical dilemmas of the profession are tackled

The topics are explored in connection with "guida al tirocinio"

#### **Prerequisites**

Social culture basics, good logic skills, synthesis skills, writing and oral communication.

## **Teaching methods**

Lectures, group discussions, group and individual activities, video and image projection, testimonials

#### **Assessment methods**

The verification of learning will take place through a written test and an oral test:

- written exam based on the reference texts, aimed at evaluating both the learning of the contents by the student and his capacity for re-elaboration and argumentation. They will give rise to evaluations of excellence: the possession of the required contents of the discipline and of good skills for further study; the ability to link the main topics covered in the course and the use of an appropriate language with respect to the specific nature of the discipline. They will give rise to discrete evaluations: the possession by the student of a good knowledge of the contents and of a good ability to link the topics covered, the use of an appropriate language. Sufficient assessments will be carried out: the achievement of a minimal knowledge of the subjects dealt with by the student, even if there are some training gaps with difficulties in the connection of knowledge and the use of a sufficiently appropriate language. They will give rise to negative evaluations: difficulty of orientation of the student with respect to the topics addressed in the exam texts, training gaps and the use of inappropriate language.
- oral exam useful to test which the degree of internalization, critical analysis and practical application of the code of ethics. The student will be asked to analyze a part of the deontological text. It will give rise to excellent evaluation: the ability to apply practical ethical principles, the ability to critically analyze content and manage ethical dilemmas. It will give rise to a discrete evaluation: an acceptable practical application of the contents of deontology, the possession of a good critical capacity and the identification and management of potential ethical dilemmas. It will give rise to a sufficient assessment: sufficient practical application of the deontological contents, sufficient critical competence and the identification of ethical dilemmas with little management capacity. It will give rise to an insufficient evaluation: the insufficient contextualization of the contents of deontology, the insufficient critical capacity and the analysis of ethical dilemmas.
