## COURSE SYLLABUS

### **Criminal Law (crimes Against Public Administration and Administration of Justice)**

#### **Learning objectives**

The course aims to provide students with the interpretative tools to discuss the cases (crimes against public administration and justice) that will be treated in class.

The ultimate goal is to improve the critical and application skills of future lawyers.

#### **Contents**

The course will focus on crimes against public administration (corruption, bribery, abuse of office, etc.) and against the administration of justice (aiding and abetting, false testimony, slander, etc.).

The various crimes will be illustrated starting from their classification in the constitutional and supranational context; the requirements will then be analyzed also in the light of the relevant jurisprudence.

Ample space will be dedicated to the cases, which will be distributed and discussed in class.

Compatibly with the availability of the students, the final exam can be optionally carried out through participation in a simulated trial

## **Detailed program**

The main crimes against the public administration (embezzlement, bribery, various figures of corruption, disturbed freedom of enchantments, abuse of office, omission of official acts, violence or threat to public official, outrage to public official, abusive exercise of the profession ), after illustrating also the figurr of public officials and public service employees; the main crimes against the administration of justice (omitted denunciation by p.u .; simulation

of crime; slander; false testimony; aiding and abetting; various figures of false information to judicial authorities)

## **Prerequisites**

Students must have previously passed the criminal law exam

## **Teaching methods**

Case study method, after illustrating the relevant crime figures.

In the Covid-19 emergency period, the lessons will take place remotely asynchronously (uploading the lessons via the Kaltura platform, visible in Webex) with events (test about lessons, case discussion, and simulated trial) in synchronous videoconference; in principle two weekly lessons will be held remotely and one synchronous (the last ones through webex).

## **Assessment methods**

for attending students the opportunity to take the exam by discussing the simulated trial carried out at the end of the course; otherwise oral exam
