### Contents

Violence, mistreatment and sexual abuse of women are unfortunately present in everyday social life and often go unpunished because they are acted in a relationship. Every type of violence leaves in the victim a pain that lasts over time, in addition to the risk of never seeing a true and full punishment of the serious offense committed by the attacker, also due to numerous missed reports and complaints for fear of retaliation: the result is that the woman can not start a path to get out of the circle of violence. The phenomenon is terrible: in Italy in 2017, a woman was killed about every two days. Added to this are numerous other types of violence, often not intercepted, which may over time lead to many other victims. According to ISTAT data, about 7 million women have suffered a form of abuse during their lifetime. Nurses and all health professionals are called upon to play a very important role in identifying and managing these situations, but above all in the prevention and protection of the health of victims.

The elective course aims to sensitize the students of the Degree in Nursing (future health professionals) to the importance of the correct recognition of the problem of abuse / maltreatment and a qualitatively advanced care approach, which can not be separated from the integration of different skills, resources and professional figures, essential for building a synergistic path of hospitality and care.
