Learning objectives

Critical understanding of diagnosis and treatment aspects related to core psychopathological features Introduction to clinical practice with particular reference to Personality Disorders

Contents

Aim of the course is to introduce the student to the study of (I) advanced clinical diagnosis and defense mechanisms, (II) personality organization/ personality disorders/ narcissism (III) Affective Disorders, Anxiety Disorders, Addiction Disorders.

In order to do so, the course will provide basic notions on contemporary clinical treatments.

Detailed program

- Diagnosis of mental disorders (DSM-5)
- Defense mechanisms
- Psychodynamic assessment; personality organization and disorders
- Advanced clinical features of Affective Disorders, Anxiety Disorders, Addiction Disorders, Personality Disorders

Prerequisites

General knowledge of Psychopathology (DSM-5 diagnostic criteria) and Dynamic Psychology (Psychodynamic Diagnosis and basic knowledge). We encourage students lacking such prerequisites to ask for basic references (via e-mail or during classes).

Teaching methods

During the Covid-19 emergency period, lessons will take place remotely asynchronously with synchronous videoconferencing events.

Supplementary materials - if possible - will be available on the e-learning platform.

Assessment methods

In the Covid-19 emergency period, exams will be oral and only telematic. They will be carried out using the WebEx platform and on the e-learning page of the course there will be a public link for access to the examination of possible virtual spectators.
