Aims

The course provides students with the expertise in high-risk maternal and foetal - neonatal morbidity and mortality.

Contents

The student will be able to plan an evidence based midwifery care to the mother with urgency or emergency conditions. The student will be able to plan an evidence based midwifery care to the newborn with urgency or emergency conditions. The student will know the definition of urgency /emergency, and will implement the techniques of communication among health care workers.

Detailed program

MIDWIFERY CARE IN EMERGENCY MED/47 Referring to the Midwifery Partnership Model, Midwifery Management and Rating Scales in Obstetrical-Gynecological and Neonatal Sciences, the student will know: The clinical risk management system used in emergencies TRIAGE; Apply the Midwifery Assessment in Emergency condition; Apply scientific principles and procedures in the field of Midwifery care in case of: emergencies in first, second and third trimesters of pregnancy, to the urgencies bleeding of pregnancy, postpartum and postnatal period; Apply scientific principles and care procedures (in collaboration with doctors anesthetists) in the management of non-invasive and invasive methods for monitoring of vital signs; Apply scientific principles and procedures in the management of life-saving drugs (blood products, blood transfusion; Adopt the recommendations

of the Ministry of Health for the safety in the operating room; Know and apply the algorithms of cardiopulmonary resuscitation BLS-D, PBLIS-D, ACLS (with practical exercises); Know and apply Obstetric diagnosis (according to ICF classification) and MEOWS or M-EWS Score; know the procedures to prepare dead body in case of Maternal death.
