#### Course title

**Fundamental concepts of aesthetics: beauty, art, society**

#### Topics and course structure

The course will explore some of the most significant concepts and moments of modern aesthetics. In the first part, after an introduction on the birth of modern aesthetics as a philosophical discipline, we will focus on Kant's conceptualisation of the beautiful the sublime and on Schopenhauer's aesthetics. In the second part, we will consider the rethinking of the notion of the beautiful and the role and function of art in industrialised societies in Adorno-Horkheimer and Benjamin, then moving to the problematisation of the Western idea of the beautiful to be found in Jullien's intercultural aesthetics.
