Aims

The Legal Medicine in the social context and its relationship with the judiciary system. Mandatory complaints, certificate, medical records, 'referto', 'denuncia di reato', technical advice and expertise. Elements of forensic psychopathology. The damage to the person and duty of compensation. Consent to health care, professional secrecy. Legal capacity, civil capacity, chargeableness. Murder, infanticide and feticide, beatings and bodily injury, rape, abortion and criminal law relating to abortion. Medical liability. Forensic pathology: causal relationship, causes and types of injuries, forensic toxicology. Thanatology and judicial inspection. Hospital and forensic autopsy. Sudden death (adult and infant). Identification. Bioethics and medical deontology (human experimentation). Assessment of death and removal of organs for transplantation, correction of sex, mandatory medical treatment. Protection of occupational accidents and diseases; compulsory insurance against invalidity. Life, accident and sickness private insurance
