# Learning objectives

The course aims at equipping students with theoretical instruments for analysis and argumentation useful to understand the different ethical-legal questions arising in the various bioethical fields. In so doing, law students will learn to correctly elaborate legal reports, provide ethical-legal counselling, and write well argued opinions in bioethical issues in their future careers. Students will be asked to analyse both relevant court decisions concerning ethical issues as well as to learn how to deal with selected ethical cases.

#### **Contents**

Bioethics deals with ethical-legal questions arising from interventions of biomedicine and biotechnology on humans, animals, and environment. This field includes a variety of topics. The 'traditional issues' in Bioethics range from end-of-life to reproductive technology, whereas the 'frontier issues' in Bioethics concern developments in Artificial Intelligence and Human Enhancement.
