The course aims to provide students ability to understand the relationship between law and society, analyzing the law as social action, as an expression of cultural, ethics and social values.

Contents

Sociology of law considers legal phenomena as social phenomena and tries to understand their relationships with other social phenomena.

The course aims to offer, on the one hand, a sociological interpretation of current developments of legal phenomena and, on the other hand, a deeper evaluation of some special topics with particular regard to the social aspects of fundamental rights and to changes in family and its regulation.
