Learning objectives

Main aim of the course is to develop *critical thinking* through knowledge, understanding, and analysis of theories and methods that characterise the legal domain and impact the legal viability. Thus, future legal experts will be able to correctly employ existing legal instruments or to elaborate new ones in order to face and regulate the complex technological-scientific questions, which are a relevant feature of the Information Society.

Contents

The course focuses on the analysis of conceptual tools and argumentation strategies elaborated by the philosophy of law inspired by the analytical-linguistic approach. Particular attention will be paid to the analysis of the constitutional rule of law and to the relationship between law, morality, and science.

Detailed program

Theories and methods of the law are framed within the philosophical-legal reflection. There are different approaches to Philosophy of law based on the general distinction between analytic philosophy and synthetic philosophy.

The course focuses on the analysis of conceptual tools elaborated by the philosophy of law inspired by the legal-

positivist and analytical-linguistic approach. After clarification of nature and function of the philosophy of law, of its role in the education of jurists and after an overview of linguistic theories, the course will focus on the investigation of important theoretical contributions on the part of the philosophy of law inspired by the legal-positivist and analytical-linguistic approach to the complex relationship between the Law, Science and Technology. Particular attention will be paid to the analysis of the constitutional rule of law and to the relationship between law and morality.
