# Laboratorio 8 - Politiche migratorie

#### Learning objectives

- -provide students with an overall knowledge of politics concerning the presence of immigrant populations in Italy and Europe
- -teach students operative skills about international migrations, to be used in professional activity of social workers

#### **Contents**

The contents involve an introduction on politics concerning immigrant populations and on most important developments and thematic issues about migration in Italy. Flexible deepening moments will then follow, also through experiences of direct contact – if practicable - with situations and services that involve immigrants in Milan.

# **Detailed program**

The program will develop following subjects, taking into account also knowledge and interests expressed by participants.

### International migrations

- -an interpretation of migrant flows at a world and European level
- -old migration/new migration/transition migration countries

- -the Global Compact on Migration
- -the impact of Covid-19 and the call on European solidarity
- -main reasons for migration to Italy

#### The "Asylum planet"

- -routs, landings, origins, forced migrants, protection application and status, foreign unaccompanied minors
- -responsibilities for asylum matters and international obligations; -the law 179/2020
- -resettlements and relocations,-the reception system,-the diffused model,-humanitarian and legal flows
- -migration at pandemic time; -recent developments

#### "Permanent" immigrants in Italy

- -the relevant stages
- -the present situation: origins, locations, social-demographic data; the regularization laws
- -indicators of migrants' rooting in Italy: acquiring Italian citizenship, migrants with permanent residence permit, "second generation", school integration, labour insertion, access to social performances and services
- -foreign migrants conditions in pandemic time
- -Lombardy: foreign residents and communities

#### **Prerequisites**

Sufficient learning, writing and oral communication skills

#### **Teaching methods**

After a more theoretical general introduction, the Lab intend to promote a strong participation of the students.

In preference it will be conducted by:

- -face to face lessons
- -presentation of researches and data on specific aspects of migration
- -exercises in computer Lab
- -direct contact if practicable with relevant migrant's situations in Milan

#### Assessment methods

Final evaluation of "approvato" (3CFU) based on:

- -active presence and involvement of the student
- -card on consulted web sites concerning migration
- -brief paper developing a subject of the program worked out from theoretical moments, documentation and experience
