## SYLLABUS DEL CORSO

### Cittadinanza: Conflitti, Diritti, Genere

#### Learning objectives

The teaching program is aimed at analyzing issues, which are politically relevant at the global level, recurring to a theoretical, normative and critical approach. In particular, the course is interested in highlighting fundamental concepts in social and political philosophy, comparing them to hot issues debated in the public sphere

#### Contents

The course will be structured into two main parts: an introductory section and a monographic one focused on truth and lie in politics and in the public sphere. First part - Historical, theoretical and pragmatic meanings of the concepts: citizenship, democracy, human rights, justice, freedom, equality, solidarity, power, recognition, gender, violence. Second part: examples concerning: hate speeches, fake news, populism, negationism, pandemic crisis

#### Detailed program

A detailed program will be presented during the first lecture of the course and published on line.

#### Prerequisites

Basic knowledge of political theory and the functioning of democratic institutions.

Learning attitudes and engagement in working groups.

Interest in argumentation and active participation in debates.

Writing skills in relation to the chosen paper's topic.

## Teaching methods

Lectures; case-studies analysis; working groups; students' presentations; seminars with Italian and international guests; multi-media means. Lectures will be also in English.

## Assessment methods

Oral exam on the basis of a paper, drawn up according to the indications provided by the professor. Attender and non-attender students will have different information on the drafting of the paper. International students can take the exam in English.
