Course title

Cultures and Societies of the Americas

Topics and course structure

The course will analyse the social construction of the categories of "land/territory", "ethnicity/race" and "nature/environment" in Brazil, paying particular attention to the Amazon area, but also drawing appropriate links with other North and South American contexts. . It will discuss not only the political role that these concepts assume in the identity and territorial claims of indigenous peoples and quilombolas (predominantly rural communities of descendants of African slaves), but also some characteristic features of the cosmologies of these groups.

The course is composed of three main tjemait cores:

1. First, the so-called "indigenous question" will be reconstructed, with emphasis on the anthropological theories developed to interpret it. We will also discuss the social role of anthropologists in the territorial claims of indigenous peoples.

2. Secondly, we will analyse the way in which the "racial" question (on the one hand, the ideology of racial democracy and mestizaje; on the other hand, the policies of "whitening") has taken shape in Brazil, comparing it with the case of the United States. We will then see how it has been intertwined with the territorial claims of the quilombolas. Finally, we will mention the theme of socio-environmental justice.
3. Finally, starting from an anthropological deconstruction of the nature-culture dichotomy, we will show how the sense of belonging to a territory is closely linked to specific local cosmologies that imply contextually variable ways of conceiving the relationship between the human and non-human worlds. These issues will be discussed starting from Eduardo Viveiros de Castro's perspectivism and Philppe Descola's ontologies, in dialogue with more recent multispecies approaches.
Objectives
Students are expected to acquire specific knowledge about ethno-racial and territorial issues that characterize the Brazilian context, learning to draw appropriate connections with cultural, social and political dynamics that characterize the rest of the continent. They will also acquire specific expertise on Amazonian cosmologies and the main theories developed to interpret them.
Methodologies
Lectures and class discussions, with eventual use audio-visual materials.
