Course title

Introduction To Civil Law

Topics and course structure

The course is structured as an introduction to Italian Private Law and to the fundamental principles of the Italian Civil Code.

Principal source of law in Italian civil system is the Civil code. Classes aims to study, mainly, the Italian civile code and the most important laws.

Basic notion of the historical formation of the Italian Civil code. Fundamental principles of Personal rights - Property law - Obligations - Contract law - Tort Law - Consumer Law - Family law - Succession.

Objectives

Acquire an overview of the Italian Legal system and acquire knowledge of the fundamental principles of the Italian civil law.

Knowledge of the structure and fundamental principles of the Italian Civil Code. Acquire the connection between the law and the practical applications of the juridical rule.

Develop a basic ability to analyze a rule of law.

In Economics, Private Law course aims to give juridical knowledge to understand the importance and limits of private autonomy, both in social life and in a business activity.

Methodologies

Classroom lectures, in Italian language, with powerpoint presentations.
