Cittadinanza: Conflitti, Diritti, Genere

Learning objectives

The Course aims to address issues of global political relevance, according to a theoretical, normative and critical approach, emphasising ongoing social changes.

In particular, the Course aims to introduce fundamental concepts of political and social philosophy, confronting them with issues debated in the public arena, especially in the light of pandemic, climate and war emergencies.

Contents

The Course will be divided into four main parts:

1. Concepts of political and social philosophy: citizenship, democracy, human rights, justice, freedom, equality, solidarity, power, recognition, gender, violence.
2. In-depth monograph: the question of truth and lies in politics and the public sphere, examining fundamental texts in political philosophy (especially Arendt and Habermas);
3. Workshop exercises: students will be invited to work on fake news, hate speech and denialism, as conveyed mainly through social media;
4. Presentations: students will present their work from the analysed cases and reference texts.

Detailed program

The extended course programme will be presented during the first lecture of the course.

Prerequisites

- Basic knowledge of political theory and the functioning of democratic institutions.
- Willingness to learn and work in groups.
- Interest in argumentation and participation in debate.
- Ability to write on a chosen topic.

Teaching methods

Lectures; analysis of case studies; group work; presentations by students; seminars with Italian and foreign guests; use of multimedia tools.

Lectures will also be held in English.

Assessment methods

Oral examination on the basis of a written paper written according to the instructions provided by the lecturer. Different modes of writing are provided for frequent and non-frequent participants.

Foreign students may write and take the oral examination in English or in another language to be agreed upon.
