## SYLLABUS DEL CORSO

### La Logica e il Metodo della Comparazione nelle Scienze Sociali

#### Learning objectives

The course aims to address the fundamentals of comparative method through a deepening of approaches, techniques and tools of sociological and political research. The main objective of the course is to provide students with the necessary knowledge and skills to define a consistent and rigorous methodological research design, through the presentation of the main theoretical and empirical reflections.

By the end of the course, the student will be able to define a methodologically rigorous comparative research design.

#### Contents

The course is divided into two parts. The first part will be dedicated to presenting the characteristics, aims and methodological problems of comparative analysis in the social sciences. Particular attention will be given to analyse and discuss aspects of similarity and difference with the logic of case studies. In the second part, in addition to the discussion of some readings and presentation of some comparative empirical research, there will be exercises with students in order to prepare a paper that will be subject to final evaluation.

## **Teaching methods**

For non-attending students, the evaluation will take place at the end of the course by means of an oral examination.
