### Law and Professional Organization (Monza)

#### Aims

The course provides students with the concepts relating to the health legislation of interest to the midwifery profession, professional liability, bioethical issues in health care.

It also provides basic knowledge of labor law and business economics.

#### Contents

The student will be able to know the concepts related to medical-legal activities, health protection, professional secrecy, criminal law, the definition of death assessment, health responsibility, the protection of maternal and child health. the student will be able to know the concepts related to the principles of business economics, with specific interest for public administrations. The student will be able to know the main rules on the midwifery profession and their field of activity and responsibility. The student will know the ethical, bioethical and deontological problems emerging in the obstetric profession, the rights of the assisted patient. The student will be able to know the concepts related to the employment relationship and the independent work relationship.

#### Detailed program

FORENSIC MEDICINE MED/43: The forensic medicine discipline: purpose and functions. The medico-legal methodology and the study of causation in medical malpractice cases. Medical-legal activities (certification, mandatory reports). Informed consent in medicine (L. 219/2017), professional secret, health records collection and health data protection (GDPR 679/2016). Criminal law: personal injury; homicide, infanticide; female genital mutilation (L. 7/2006). Special Italian norms: medical malpractice (L. 24/2017 Gelli-Bianco), legal abortion (L. 194/1978), sexual violence (L. 66/1996), domestic violence (L. 119/2013). Tort law: forensic evaluation of

malpractice cases and compensation. Overview of autopsy (for judicial and health purposes), especially in neonates and pediatric patients. Definition, detection and declaration of death (abortion, stillbirth, natural, sudden, iatrogenic, violent death).

APPLIED ECONOMICS SECS-P/06: General principles of business economics. Economic measures system of health authority: general accounting, financial statement, analytical accounting. Income: financial system of health service. The costs: based notions of cost analysis. Programming and control tools.

LABOR LAW IUS/07: The employment relationship. The sources of discipline. The constitutional foundations. The typical features of the employment relationship. The employment relationship with the public authorities or a private employer. The main directions of labor market reform introduced by Legislative Decree 10 September 2003, n.276 and law Nov.4, 2010, 183. The discipline of the worker: the code of conduct; the disciplinary proceedings, sanctions. The means of protection of the employment relationship. The means of protection of rights. The statute of workers, the right to strike in essential public services. Right of working mothers (Legislative Decree 151 \ '01 and subsequent amendments and additions). The self-employment: Forms and methods of independent exercise of the profession.
