# Learning objectives

The course aims to analyze the deviant careers considering the risk factors, the turning points, the transitions and the trajectories that define every path of life.

The premise from which we will leave is that the paths leading to both entry and exit from deviant careers (desistance), contrary to how they are often told, are mysterious and enigmatic. For this reason, in order to accommodate their ambiguity, we will resort to the evocative power of selected fairy tales that will guide a shared reflection.
