#### Course title

SOCIAL SERVICES POLICIES - A-L

#### Topics and course structure

The course aims to provide general notions on the topics of Social Policies and the Welfare State. Starting from the analysis of the evolutionary dynamics that have characterised the various phases of development of the European Welfare State, the course will address the specific features of the most important social policies, paying particular attention to the Italian context and highlighting the decisive role played by certain structural dimensions such as work and family. In particular, the following aspects will be explored:

- the historical evolutionary perspective;
- the description and contextualization of the main phases of development of the Welfare State;
- the theories for the analysis of the Welfare State;
- the definition of the main empirical approaches;
- the transformations of work and the impacts on social policies;
- focus on the Italian case;
- the demographic dimension and the changes in family structures;
- welfare models and schemes;
- the main areas of intervention of social policies.

#### Objectives

The course aims to promote, through the teaching and the constant and participative attendance of lessons, the

following learning, in terms of:

- **Knowledge and understanding:** provide the theoretical notions that allow to identify the historical development, characteristics and target population of the main social policies, as well as the economic and social macro-factors that condition their development and functioning;
- **Ability to relate different knowledge and models:** to promote analytical and critical skills to be able to judge the effectiveness and efficiency of social policies in terms of needs met, of justice and of cost-effectiveness
- **Ability to apply knowledge and models:** to provide the skills that allow to identify the needs of specific sectors of populations and link them to appropriate social policies, as well as the conceptual and analytical tools necessary for the study and understanding of social policies that directly and indirectly impact on and integrate with the work of an educator.

## Methodologies

The methodologies used during the course will be the following:

- frontal lectures, with the aim of providing students with a common level of knowledge on the main theoretical aspects;
- lectures by professionals and scholars working in the field of specific social policies, in order to deepen their knowledge of the professional contexts in which graduates in educational sciences will be able to operate.
- class discussion on the materials (slides and articles) and the content of the lectures by professionals and experts
