## SYLLABUS DEL CORSO

#### Course title

Facing the Other. Europeans and natives of far-off worlds

#### Topics and course structure

An approach to literary studies conceived as critical representation of culture and of cultures, without predetermined linguistic or chronological boundaries. The analysis of texts, themes and poetics aims to put in evidence the relationship between things and words, discourse and reality, historical contexts and symbolic forms. After a general introduction to Comparative Literature, this year the lecture course will focus on some literary works, belonging to different historical periods, which represent Europeans facing the natives of far-off worlds. After a premise devoted to William Shakespeare and the imaginary Caribbeans of the *Tempest*, we will deal with Kipling's *India*, Conrad's *Congo*, Flaiano's *Ethiopia*, and Coetzee's *South Africa*. The issue is declined in very different ways, from refusal to fascination, from identification to the loss of self; nevertheless, the experience always upsets the protagonists and shakes the perception of their own identity. Facing the Other questions oneself and focuses to revise one's ideas of humanity.

#### Objectives

The student will become familiar with the idea that literature represents not only a thesaurus of themes and topics which most human sciences usually deal with, but also a way to develop formalized patterns of experience, in which a key role is played by formal features (language, style, modes, genres).

## Methodologies

Lectures and discussion. Text analysis: linguistic and rhetorical features, narrative modes, cultural patterns. Exercises in oral presentation.
