Course title

Medical Anthropology

Topics and course structure

The course aims to shed light on the social, cultural, political and economic dimensions of the body, health, illness and systems of care, with particular reference to the geopolitical arrangements and socio-economic inequalities that exert their impact on the health of the planet's various populations. These issues will be examined throughout theoretical and ethnographic paths declined in three thematic cycles.

COMMON SECTION

1. *Introduction to medical anthropology*: presentation of the main paradigms and theoretical orientations; narrative approach (classical concepts of illness, sickness, disease, explanatory models); critical medical anthropology (social suffering, political violence and health inequalities from a global health perspective); the contribution of medical anthropology and ethnopsychiatry in understanding mental health.

OPTIONAL SECTION

2) *Applied medical anthropology*: the role of medical anthropology in social welfare and care services, relations with health institutions, the professional and theoretical contribution of anthropology in the development of public health and prevention policies in national, international and transnational contexts.

3) *From medical anthropology to the anthropology of care*: the contributions of medical anthropology in understanding demographic transformations and global aging.

At the end of the optional section, students will be present to the whole class an individual or group work about

specific topics of each thematic cycle. The organization of the groups, topics and dates will be agreed during the first lesson.

Objectives

By means of this teaching, with constant and participative attendance of the lectures and the Laboratory connected to the course, we intend to PROMOTE the following learning, in terms of

Knowledge and understanding

The teaching of medical anthropology aims to provide students with in-depth knowledge and critical analysis skills on the main topics of scientific interest in the discipline, integrating them in a historical perspective and placing them in the contemporary theoretical and methodological debate. At the end of the course, students are therefore expected to have understood methodological and applicative aspects of the anthropological approach to the themes of health, illness and cure.

Ability to relate different knowledge and models

By the end of the course, students are expected to have acquired critical competence in relation to the different theoretical perspectives that have explored the cultural, sociological and political implications of the body and illness;

Ability to apply knowledge and models.

At the end of the course, students are expected to have developed critical skills and the ability to independently orient themselves among the themes and topics addressed, also exploring the possibility of formulating novel and original research interests in a personal way.

Methodologies

Lectures; seminar meetings; viewing, analysis and discussion of multimedia and documentary materials; cooperative learning sessions; handouts.

Online and offline teaching materials

As the course progresses, bibliographic references and supplementary teaching materials will be progressively uploaded onto the e-learning platform to enable students to carry out group activities and further investigate any topics of personal interest. In addition, this will enable non-attending students to regularly follow the progress of the lectures and to find concepts and materials useful for independent examination preparation.
