#### Course title

The concept of "power" between Foucault and Deleuze

#### Topics and course structure

This class aims to examine and discuss Michel Foucault's conception of "power": From microphysics to biopolitics, from disciplinary power to power of control, and to "resistance points". We shall be guided by the quite extraordinary lectures that Gilles Deleuze devoted to this conception shortly after Foucault's death.

#### Objectives

Through this teaching, by means of an active attendance to lectures, we intend to promote:

- Knowledge and understanding of the models of self-understanding of the human being - understood both as a singularity and in relation to different social formations - developed within the Western philosophical tradition, with particular reference to the ontological, ethical, political, religious and cultural variables in general that structure the fields of experience and sediment in collective mentalities;
- Ability to put into relation different paradigms, grasping the recurring tension between historical and transcendental approaches;
- Ability to apply knowledge and models, contributing to the development of critical skills for interpreting cultural contexts, and to the autonomy of judgment with respect to the theoretical tools and research protocols deployed.

## Methodologies

The course makes use of different methodologies: lectures; class discussions on materials such as texts (including those scheduled for the exam), slide presentations, audiovisual documents provided by the lecturer or independently proposed by students; participation of scholars presenting current research.
