Prerequisites

Participation in the exam of 'Criminal Law. Special Part' requires the passing of the exam of 'Criminal Law' (Academic Regulations a.y. 2022-2023).

Teaching methods

Analysis of the main offences in the light of scientific literature and case law, study and collective discussion of practical cases.

Classroom teaching is characterised by a lab-based method, engaging students in the drafting, presentation and discussion of legal advice.

Assessment methods

Written test, consisting of the writing of a legal opinion.****

In particular, the following will be assessed: the ability to refer to the arguments in a manner appropriate to the specificities of the subject and according to correct logical-systematic canons, the ability to link the various criminal law institutions, exegetical correctness, argumentative skills, technical-expressive skills, abstract and practical reasoning skills, and the ability to work in a team.
