## Elementi di Storia del Diritto Medievale e Moderno - A-L

### Learning objectives

The course aims to provide an overview of the historical evolution of law from the Middle Ages to the Contemporary Era in order to better understand the Present and its future developments. Students will be provided with knowledge of legal terms and categories both logical and conceptual. The course also aims to help students understand the historical evolution of legal systems, gain a critical awareness towards the law, study the past to acquire a broader understanding of the modern legal concepts, learn to know the main European schools of thoughts, adopt a comparative approach to study law.

#### **Contents**

The course is aimed at providing students with the theoretical skills and knowledge to understand the history of the legal systems in Europe from the Middle Ages up to the 20th century. It is geared to pick out the effects of the social, legal, economic, political, and religious changes occurred across the centuries and to give an insight into the links among legal science, law, and jurisprudence. All students will be given chances to learn the most important events in the Italian and European legal history in order to provide a pathway into understanding of the links and breaks that mark the history of law sources, legal practice, legal science, power exercise, down the centuries.

#### **Detailed program**

Notes on the law in the Early Middle Ages (Germanic peoples and the feudal system); notes on the medieval ius commune; the law in the Modern Era (Supreme Courts; the New World; the Reformation); the doctrine of natural law; the Enlightenment; from the French Revolution to Napoleon; the codes in France and in Austria; the law in Italy after the Unification; the Fascist regime.
