### Learning objectives

#### Knowledge and understanding

- Understanding communication and interpersonal dynamics in the family context
- · Knowledge and understanding of the emotional aspects of family crisis and its management
- · Knowledge of tools aimed at improving the welfare of people living a conflict

#### Applying knowledge and understanding

- Ability to bring within the working team the knowledge learned, collaborating effectively
- Ability to traferire content learned in practical exercises.

#### Contents

The lab-course aims at favouring the acquisition of knowledge on family dynamics consequential to crisis and separations, with particular attention towards the promotion of dual parenting and the intervention of family mediation as a tool of the Alternative Dispute Resolution (ADR).

Through direct theoretical application, the lab-course explores emotional aspects of parents and children within separation conflict, and the principles and the main objectives of family mediation

#### **Detailed program**

- Social climax around separation conflict
- Psychological dynamics of separations: amongst adults, in children and teenagers, within family relations
- Re-organization of family relations before or after separation: children's needs, adults needs
- Psychological consequences of the legal and judicial process around parental separation
- Sustaining parental responsibilities in order to effectively govern conflict
- Activation of the resources and spontaneous capabilities of the people involved
- · Promotion of symmetry and reciprocity in mothers and fathers care
- · Principals, objectives and rules of family mediation

#### **Prerequisites**

Knowledge of the basics of Developmental Psychology and couples and family dynamics.

Availability to discussions and active participation.

#### **Teaching methods**

- Group work on articles and other material
- Discussion of documents and readings
- Discussion of cases
- Pratical guided exercises

#### **Assessment methods**

Exercise and discussion with the Professor.
