Course title

Historical anthropology

Topics and course structure

Historical anthropology is a field of study across anthropology and history born out of the awareness that societies can only be understood if they are analysed historically. Different societies have different conceptions of time and different histories. In order to study social life in a diachronic perspective, historical anthropology combines archival research, ethnography, oral history, material traces, etc.

The course tracks the emergence of historical anthropology, within different academic traditions. It then presents an outline of the main discipline methodologies and research arena.

Part of the classes are seminar-based. We analyse and discuss some historical-anthropological essays, reflecting on the sources they are built upon: on sources' context of production and preservation, on their materiality and their possible uses.

Objectives

This course, with constant class participation, aims to promote:

- an awareness and understanding of the main theoretical issues in historical anthropology
- the ability to apply anthropological-historical analysis to different cultural settings and to relate different understandings of history to each other
- the ability to apply the knowledge and models of historical anthropology to specific situations and contexts.

The course examines the use and value of historical documents in anthropological research. We will explore the nature of different documentary sources, oral history and oral tradition. We will focus on the skills needed to evaluate and use of documentary and oral sources to approach the past ethnographically.
