Contents

The laboratory will focus on the analysis of the clinical interview, with the aim of convey how the information collected during the interview and the observation of clinician-patient interactions are usable in understanding the case in either clinical and research settings. Practical examples of clinical interaction analysis will be discussed in

view of recent research contributions on the topic.

Detailed program

- Theoretical introduction to clinical interview analysis for diagnostic and case understanding purposes.
- Value in clinical interview and therapist-patient interaction analyses in research and clinic contexts.
- The diagnostic and therapeutic process as privileged contexts of clinical observation.
- · Basic information on methods and assessment tools.
- The areas of functioning and the psychological constructs observable in the interview.
- The main methods and tools of clincal interview analysis and the organization of the collected material.

Prerequisites

Basic knowledge of clinical psychology.

Good knowledge of written English.

Familiarity with the use of computers (Office package or equivalent).

Teaching methods

Example clinical material; presentation of relevant content; classroom work and active discussion; consultation of texts and scientific articles useful for understanding the topics treated.

Assessment methods

In order to pass the laboratory, students must have attended at least 75% of the lessons and will have to participate in some group work during the lessons, the outcome of which will allow the approval of the laboratory.
