2- Friday 15 December 9am-1pm (4 hrs/hrs) *Sensitive to the body. The embodied dimension in research*

Among the fundamental skills of every qualitative researcher is the awareness of one's own bodily presence. The lesson, which includes extensive moments of interaction and experimentation, intends to raise awareness of this awareness through knowledge and practices of artistic, performative and participatory bodily expressiveness, in their encounter with the themes of individual and community training and education. 4-Thursday 11 January 9am-1pm (4 hrs/hrs)

*Memory, participation and digital ecosystems*

Through the examination of national and international case studies, the lesson will reflect on strategies and projects implemented by cultural institutions and local communities aimed at the conservation, consolidation and dissemination of intangible Cultural Heritage, using the resources offered by the digital ecosystem. 5- Thursday 11 January 2pm-6pm

*Participate, interpret, mediate, educate? Tocati, a shared programme for the preservation of Traditional Games and Sports.*

Starting from an experience of community-based patrimonialisation, whose social actors - a network of cultural associations and groups of practitioners of Traditional Games and Sports - chose to refer directly to international normative instruments by promoting a UNESCO candidacy, we will analyse the significant moments that led to the registration of Tocati, a programme shared by networks active in 5 European countries (<https://ich.unesco.org/en/BSP/tocat-a-shared-programme-for-the-safeguarding-of-traditional-games-and-sports-01709>), showing how, starting from the needs, projects and desires of groups, communities and civil society organisations, activities are being developed in which different levels of institutional, scientific and political action meet.

We will reflect on some developments of this experience, both in the field of research aimed at the inventories of intangible heritage, with the contribution of Archivio di Etnografia e Storia Sociale (AESS)-Regione Lombardia, and in the field of formal and non-formal education, with the capacity-building initiatives - "Days of the Intangible" - carried out at the national level, in collaboration with the Istituto Centrale per il Patrimonio Immateriale (MIC). 6. Friday 11 January 2pm-6pm *Museum Anthropology of Intangible Heritage. Participatory practices and community museums*

The aim of the lecture is to examine the dynamics and processes that, in the field of anthropological museology, develop through participatory processes of patrimonial "construction" and access to material and immaterial collective goods. The lecture will also be an opportunity to critically examine cases and experiences of participatory patrimonialisation, in which community museums are the leading actors. Another relevant aspect will be the relationship between intangible heritage and practices of "participatory restitution".

7. Thursday 1 February 2pm-6pm *The collection of oral histories as a form of intangible cultural heritage protection*

Fairy and folk tales collectors of the 19th century, who fixed the living voice of oral narrators, through writing, on a medium that would allow its preservation and dissemination, represent the dawn of the protection of intangible cultural heritage. Starting from the exploration of that model and its reasons, the discourse will come to explore - with the contribution of Prof.ssa Laura Marchetti, scientific coordinator of the project "Le Strade della Fiaba" - the very essence of oral narration, a "feminine gift", an "astute art" that has allowed over the centuries and in the most different cultures, "the only form of survival of the female word, excluded from the languages of public life", guaranteeing the possibility of developing a mental and imaginative freedom otherwise precluded to the female gender.
