Aims

After attending this course, the student will be able to:

- Identify the skills of the community nurse by describing the areas in which he/she operates to ensure continuity of care in primary care
- Describe the purposes of Health and Therapeutic Education, implement and evaluate a health education intervention

Contents

The course aims to prepare the future nurse to:

1. Evaluate the health status and needs of the person in the different stages of life (adulthood, childhood, adolescence), of the family context and know those of the community
2. Promote and participate in prevention and health promotion initiatives aimed at the community
3. Promote informative and educational interventions aimed at individuals, families and groups, aimed at promoting changes in lifestyles
4. Supervise and facilitate the paths in the various services using the skills present in the network
