The integrated course as a whole aims to achieve the following objectives:

- To understand the principles and regulations governing the organization of healthcare institutions;
- To understand the legal framework of healthcare professions, with particular reference to physiotherapists;
- To learn the health-related regulations in terms of both general framework and specific regulation in various legal fields;
- To acquire the basic elements of Occupational Medicine and the prevention system in the workplace;
- To understand the main aspects of occupational hazards, particularly in the healthcare sector, in order to prevent the development of occupational diseases.

##### MEDICINA LEGALE

General legal framework and healthcare legal framework; General principles of Legal Medicine; Deontology and protection of the person.

##### MEDICINA DEL LAVORO

The course provides students with useful information to promote health in the workplaces and to avoid behaviors that may cause occupational diseases, with particular reference to musculoskeletal disorders.
