Learning objectives

The Commercial Law mainly has as object the discipline of the entrepreneur, both from an organiza-tional and a functional and dynamic point of view, the discipline of free competition, that of compa-nies and some aspects of the securities market, the regulation of savings. Object of Commercial Law are also some contracts in which a party, always or frequently, is an entrepreneur and therefore they are usually qualified as contracts of commercial entrepreneurs.

The Commercial Law course proposes the study of the disciplines of entrepreneurs and companies.

Contents

The course is aimed at defining and explaining the essential elements of the Italian discipline of busi-nesses and companies, contained in the Civil Code and in the main related laws, stimulating the prac-tical application of the concepts covered during the lessons through participation in seminars.

Detailed program

Entrepreneur

Features and general requirements. Entrepreneur and self-employed person. The categories of entre-preneurs: commercial and agricultural entrepreneur; small entrepreneur; the public entrepreneur. Par-ticular types of company: the artisan company; the family business; the social enterprise; the agritourism enterprise; the illicit company. Start and end of the business. The statutes of entrepreneurs. The register of companies. The entrepreneur's writings. The attribution of the business activity. The auxiliaries of the entrepreneur. The company and its circulation. The family pacts.

Society

Companies: the notion of companies and types of companies. The simple society. The society in the collective name. The limited partnership. The joint-stock company. The shares, the assembly and the administration of the joint-stock company. Internal controls. Alternative administration and control systems. The modifications of the statute. The bonds. The dissolution of the public limited company. The limited partnership for shares. The limited liability company.

Prerequisites

Knowledge of Private Law and passing of the related exam are required before taking the Commer-cial Law exam. There are no prerequisites for taking part in the lessons.

Teaching methods

Frontal lessons.

All lessons are conducted in person in both lecture and interactive format:

 n.16 lessons of 3 (three) hours each and 1 lesson of one hour conducted in person in lecture and interactive format.

Students are also offered the opportunity to participate in competitive seminars, organized as exer-cises conducted in an interactive manner either remotely or in person, depending on room availabil-ity:

• n.2 exercises of 1 hour each, for each student, conducted in an interactive manner either remotely (online) or in person, depending on room availability.

The course will be taught in Italian.

Assessment methods

There are two different examination modes, and each mode still includes an oral exam on the date of the official session.

If you participate in the competitive seminars, the oral exam will cover only certain chapters of the second volume, as the seminars will test your preparation on the first volume and part of the second volume.

The oral exam consists of an interview on the topics covered in class and in the examination texts.

The oral exam takes place on the dates of the official sessions covering the entire syllabus.
