- Develop a basic ability to analyze a rule of law.
- Acquire the capability to analyse the application of the rule of law in specific cases, with reference to case law.

The course is structured as an introduction to Italian Private and Commercial Law and to the fundamental principles of the Italian Civil Code. References on the implementation of EC law in Italy. Basic notion of the historical formation of the Italian Civil code Fundamental principles of family law, succession, property law, contract law, tort law and consumer law.

## Teaching methods

Teaching methods

Lectures in face-to-face and remote mode as follows:

1. In-person lectures (classroom): 44 hours (fourteen lectures)
2. Remote lessons in asynchronous mode (Webex // e-learning) hours: 10 (four lessons)
3. Remote exercises in synchronous mode (Webex // e-learning) hours: 9 (three lessons)

The activities will also be divided into delivery and interactive mode as follows:

1. Didactics in delivery mode (DE): 40 hours
2. Didactics in interactive mode (DI): 23 hours

## Assessment methods

### Assessment methods

The final exam is oral. An intermediate written test is expected. The written test will be delivered in the 'open-ended' mode. Overall, the examination, in the indicated phases, consists in the demonstration, by the candidate, of the knowledge of the fundamental institutes of Private and Commerciale Law. In addition, the candidate is required, both in writing and oral form, of adequate legal terminology.
