Course title

Hygiene and public health: possibly field of application in the work of the educator.

Topics and course structure

The teaching aims to provide students with the essential elements to know:

- the concepts of health, prevention and health education;
- the foundations of public health;
- the evolution of healthcare systems;
- the Italian healthcare system;
- the fundamentals of epidemiology and prevention of the main infectious diseases.

The student will be able to understand the possible role of the educator in protecting health, also through the promotion of healthy lifestyles and the analysis of the correlation between environment and health.

The lessons cover the themes of the Sustainable Development Goals (SDGs) of the UN 2030 Agenda with particular attention to the objectives:

- "2 Zero hunger" for aspects relating to food education and the influence of globalization processes on them and on hunger.
- "3 Good Health and Wellbeing": it is essential to guarantee a healthy life and promote the well-being of all at all ages.
- "6 Clean Water and Sanitation": it is essential to guarantee accessibility to primary goods and services for the entire population

Objectives

The course aims to develop the following learning:

- Understand the concepts of health promotion and prevention (primary, secondary and tertiary);
- Relate differentiated knowledge and models on the main determinants of health and the measures aimed at protecting it;
- Raise awareness of health literacy (*Health Literacy*) and processes aimed at involving the population in decisions regarding their health;
- Apply knowledge and models regarding promotion, prevention, rehabilitation and educational work in the health sector.
- Learn about the different health systems, how they were born and what implications health systems have on public health.

Methodologies

The teaching, which will be delivered in Italian, includes experiential moments of individual and group activation, accompanied by moments of didactic communication and restructuring of the theoretical frameworks of reference. All training activities scheduled for the 42 hours are carried out in person.

The lessons include the presence of a didactic part in delivery mode (theoretical explanation, conceptual in-depth analysis) and an interactive part where the interactive involvement of those present is expected (dialogical exchanges, activities supervised by the teacher such as individual exercises, group work, case work, planning).

3 lessons of 2 hours carried out in asynchronous delivery mode

18 2-hour lessons carried out in delivery mode in the initial part which is aimed at involving students in an interactive way in the subsequent part.

What is hygiene about? What is health? What does illness mean? What strategies can be implemented in the public sector to promote health?

Hygiene is the science that deals with preserving and promoting the health of the community through the defense and participation of individuals, in this sense it is fundamental to understand the influence that the distribution of income, education, safety, housing, the work environment, employment, social networks, transport and pollution have an influence on lifestyles and health policies, with particular attention to gender and racial inequalities.

What does caring mean? What does the social-pedagogical educator do in the social-health sector?

Social-pedagogical educators, working alongside doctors, nurses and different therapists, constantly find themselves managing people's health, illness and care; often without having activated a profound reflection on these themes and on the meaning that is personally attributed to them in their formation. Healthcare is experiencing a phase of rapid and intense transformation on different levels: political, economic, organisational,

scientific, epidemiological and demographic. For the educator, therefore, it becomes essential to acquire the knowledge necessary to address these issues from a pedagogical point of view.
