Course title

Istituzioni di Cultura Giapponese

Topics and course structure

The course is conceived as an introduction to the study of Japanese history and civilisation: a wide-ranging overview starting from the earliest evidence about the origins of the people and their culture, to the occurrence of Japan into the international framework in modern times (mentions to contemporary period). Focuses on some topical moments of the cultural-historical evolution of Japan, aimed to highlight contacts with 'other' cultures.

Objectives

The course aims to provide students with a basic knowledge about historical and cultural issues relating to Japan. Students will be able to effectively synthesise the acquired knowledge by emphasising the specificities of Japanese culture and integrating it with knowledge related to monographic topics (see text of choice) or possibly acquired skills in other disciplines.

Methodologies

Lectures with audio-visual aids and focus on some topics related to the current reality.

All lectures are conducted in face-to-face delivery mode:

- 21 '2-hour lectures' delivered in face-to-face delivery mode.

Thanks to *e-learning course page*, several links about reading/video materials are uploaded from time to time to deepen the topics covered during the lecture.

PROGRAMME

- The ancient age: the origins of the Japanese people and culture/formation of a unitary state/**cultural influxes from the Asian continent and 'autochthonous' evolution**
- The 'feudal age' (12th-16th centuries A.D.): the Kamakura shogunate and the Ashikaga hegemony/**early contacts with the West**/ pacification and unification of the 'country at war'.
- The Edo period (17th-19th centuries AD): introduction of the bakuhan system/Confucian philosophy and ethics/urban spaces and popular culture/**peculiarity of sakoku**
- The Meiji period (1868-1912): the Meiji Restoration and the formation of the nation-state modernisation/**westernisation or modernisation?**
- Brief synopsis 20th century.

Assessment methods

*Type of test

Written and oral test

The written test consists of a series of closed and open questions on the topics included in the text 'Introduction to Japanese Culture'.

Those who pass the written part will be admitted to the oral test, where they will be interviewed on the text chosen from the bibliography.

Registration in both written and oral examinations is required; the test must be taken in the same session.

***Evaluation criteria**

The written test will be marked from 0 to 20 points. Those who acquire at least 12 points in the written examination will be able to take the oral examination.

The points acquired in written examination will then be added to those of the oral part from 0 to 10 points to obtain a final evaluation.
