Course title

Medical Anthropology

Topics and course structure

In this course, students will develop knowledge and critical understanding of social, cultural, political and economic dimensions concerning health and body issues. In what ways are health and illness matter of interpretation and belief in different societies? How do they involve and shape social interactions and social organization among individuals and groups? How do they reflect and influence political and economic relations? To answer such questions, this course focuses on ethnographic approaches on issues regarding health and illness in different contexts worldwide.

One theme that ties together the diverse topics of the course is the production of anthropological knowledge about health, suffering, and medicine. Particular attention will be dedicated to the anthropological analysis of global inequalities linked to the field of health, in order to better understand some of the most complex contemporary contexts and issues across different ethnographic cases.

Objectives

Through this course, we intend to PROMOTE the following objectives:

*Develop knowledge and critical understanding of medical systems as systems of thought and practice. Students will become familiar with categories, theoretical perspectives and languages developed within Medical anthropology.

*Develop abilities to relate different knowledge and models related to anthropological and ethnographic perspectives on the body in its dimension as a bio-historical product.

*Develop abilities to apply knowledge and models relating to individual forms of embodiment of historical and social processes in relation to situated moral worlds. Students will be able to exercise competence in the interpretation of ethnographic research in the field of health and healthcare.

Methodologies

In the first part of the course, teaching will be based mainly on introductory lectures on Medical anthropology. In the second part, articles and chapters focusing on specific topics of the course will be discussed in form of seminar. The type of teaching activity planned for the course is exclusively that of lecture.

All in-presence meetings will be classical lectures (DE) and interactive learning (DI), averaging 50% and 50% of the total hours.

Meetings of an interactive nature include, for example, presentation and discussion of ethnographic cases viewing, analysis and discussion of multimedia and documentary materials; cooperative learning sessions.

There will be 6 hours delivered remotely in asynchronous mode to give students the opportunity to listen to the proposed content several times.

Online and offline teaching materials

During the course, supplementary materials will be progressively uploaded to the e-learning platform.
