Course title

Anthropology of Kinship and Gender

Topics and course structure

The course 1) presents different theoretical approaches in the anthropology of kinship and gender; 2) it explores the impact of feminist anthropology and gender studies on the anthropological analysis of kinship; 3) it addresses contemporary debates on reproduction and other transitions that mark the lives of individuals and households.

Objectives

The course aims to provide master student with:

- 1. knowledge and tools for a critical understanding of kinship and gender;
- 2. abilities to identify and make connections between different understandings of kinship and gender;
- 3. skills for applying specific models of kinship and gender to the understanding human reproduction and other life transitions.

Methodologies

The course consists of:

- a) Two three-hour lectures in classroom. During the first lecture, the instructor explains the syllabus structure and contents, the final exam, and grading; during the last one, she highlights the main topics covered during the course and provides further information on the final exam. A streaming connection is provided to enable non-attending students participation.
- b) One mid-course online lesson of three hours. This lesson is designed to be highly interactive, promoting active learning and engagement. In the first part, students watch audio-visual materials provided by the instructor. In the second part, they engage in small group discussions. They then present discussion results in a unified virtual classroom. Online attendance allows groups to view different audio-visual contents simultaneously and have a comparative discussion.
- c) Sixteen mixed-methods lectures of 3 hours in classroom. These lectures are structured to provide a balanced learning experience. In the first part, the instructor delivers a comprehensive lecture. In the second part, students actively participate in interactive activities, including discussing texts and exercises directly related to the lecture's topic.

Online and offline teaching materials

At the end of each section/topic, the lecturer uploads the slides onto the e-learning platform.

For some topics, links to audio-visual materials available on the web are also provided.

A collection of essays and articles (cf. bibliography point 3) is uploaded onto the e-learning platform at the beginning of the course.

Programme and references

Current debates on kinship have shown a complex correlation between the biological aspects of reproduction and human life and broader kinship relationships. This is due partly to the impact of gender studies on kiship and to a new-found interest in the body and in personhood, as well to demographic changes, and to the spread of artificial reproductive technologies and of new family forms.

The course explores some of the central issues in the anthropology of kinship and gender. It introduces key concepts such as "descent", "marriage", "domestic groups/cycles", "sex/ gender", "family", "relationality" and "care". It also analyses contemporary debates on reproductive health, assisted reproductive technologies, adoption, kinning, intimacies and family forms and dynamics.

The focus is on reproduction and other life transitions as privileged events to observe the interactions of gender, kinship, politics, religion, science and law, and to reflect on how these interrelated social fields affect relations and subjectivities.
