### **Mutamento Sociale e Vita Quotidiana**

#### **Learning objectives**

1 - *Knowledge and understanding* - The course aims to provide students with the theoretical knowledge necessary to identify and understand the challenges that social change poses to Social Work.

2 - *Applying knowledge and understanding* - The course aims to enhance students' methodological skills that will enable them to understand the relationship between Social Work, social change and life courses.

#### **Contents**

The course aims to:

discuss the relationship between sociocultural change, globalization and Social Work;  
highlight the connection between social change and life courses;  
identify global and local challenges for Social Work in the 21st century.

#### **Detailed program**

The course consists of two interdependent parts.

1. The first part will explain the basic concepts for the course (social change, globalization, gender, generations, life courses, everyday life) and provide an overview of the main research methods in Social Work.
2. The second part will discuss the most significant challenges affecting Social Work in XXI century and the consequences of sociocultural change and global transformations on people's daily lives.

## **Prerequisites**

Reasonable skills in sociology and social research methodology.

## **Teaching methods**

Lessons and seminars.

The course will include 56 hours, of which about 60 percent will be standard lectures with the use of slides and 40 percent will be interactive teaching (group work aimed at designing and setting up the paper consisting of a theoretical part and a research part).

## **Assessment methods**

Oral examination. Discussion of a research paper that requires close reading of textbooks, suggested readings and other sources, which students must comprehend, analyze, synthesize, and evaluate. The paper should consist of a theoretical part and a research part to be defined using all required readings and a selection of the recommended readings.

The paper should explore one challenge posed by social change to Social Work to be chosen from the following: a) Generational turnover and life course changes; b) Environmental crises and sustainability; c) Covid-19 crisis and post pandemic challenges to Social Work; d) Gender inequality and violence against women/GBV; e) Diversity and migration.

The paper may be written individually or in small groups (maximum 3 students/students per group). The paper should not exceed 8 pages (each of 2,500 characters, including spaces, Times New Roman 12 font) in the case of one person; 12 pages (two-person group); 15 pages (three-person group), excluding abstract, bibliography, tables and graphs.

STANDARDS FOR DEFINING THE PAPER WILL BE PRESENTED AT THE BEGINNING OF THE COURSE.
