Learning objectives

A) Knowledge and understanding

Knowing and understanding, from a historical perspective, the psycho-socio-criminological approaches to criminal phenomena, particularly those involving violence. Critical analysis of national and international literature.

B) Applying knowledge and understanding

Ability to read and interpret the relationship between crime, the individual and society in its many forms through case studies.

C) Making judgements

Developing autonomy of judgment regarding the application of socio-criminological paradigms to practical cases and the possible preventive actions.

D) Communication skills

Ability to engage in interdisciplinary dialogue and communicate extra-legal knowledge.

E) Learning skills

Ability to understand the complexity of criminal phenomena from evolving psycho-socio-criminological perspectives.

Contents

The object of criminology is the study of the delinquency, with special reference to phenomenology and typologies of crime, theories about deviance, systems of social control and rehabilitative measures.

The aim is to outline problems regarding methods and object of the criminology and study in detail, theoretically and empirically, the multidisciplinary approach to crimes and their authors.
