Learning objectives

Understand the model of restorative justice and the programs that implement it, and its application in the Italian legal context.

Understand the principles and characteristics of the restorative paradigm, also in relation to contexts other than criminal justice, with particular regard to the social and community sectors.

Introduce the main national and international legal sources that regulate the application of restorative justice programs.

Understand the role of the mediator, equiproximity, highlighting the distinctions and interactions of this role with social professions.

Experience some tools of the mediator specializing in restorative justice programs.

Deepen the contexts of applying the restorative model: in Italy and abroad, with particular regard to serious/very serious crimes.

Explore issues related to the experience of victimization.

Teaching methods

The course will be based on:

Theoretical lessons always accompanied by classroom debates and group discussions Audiovisual stimuli will be used

Exercises and group work will also be proposed

Some lessons will take place at a penitentiary institution for adults in Milan, to encourage encounters and the exchange of different perspectives on a difficult topic, such as repair after the commission of a crime.

Assessment methods

The participants will be called to actively engage in the lessons by valuing each individual's point of view.

During the lessons, assignments for analysis and reading will be given, which will then be presented and discussed in class.

At the end of the course hours, participants will be asked to prepare a brief written assignment, which will be the subject of the final exam.

In particular for attending students: starting from the lessons held, meetings at the penal institution, and the readings assigned by the teacher, students will be required to give a group presentation in class and submit a written paper, both to be done in groups.

For non-attending students: based on the readings indicated in the "reference texts" section, they are required to write a paper that illustrates restorative justice and develops an aspect of it (the VOICES contained in the Libro dell'Incontro can provide an interesting starting point). The student can choose a key word related to restorative justice and mediation, or a topic that particularly impacted them, and attempt to analyze it. Alternatively, they can link a specific conflict case and imagine a mediation intervention, such as a conflict known in their professional field for those who are already working, or in other contexts (including cinematic and literary ones). The paper should include a more descriptive section on restorative justice and mediation (based on the texts read) and a section with more personal reflection, starting from a word, a theme, or a conflict.
