## SYLLABUS DEL CORSO

### Devianza Organizzativa e Corporate Crime

#### Learning objectives

Upon completion of this course, students will know, from an organizational perspective, the types of events that fall under the category of organizational deviance and business crimes and have an analytical framework for identifying the political, social and economic impact of such events. Specifically, students will understand events analyzed from an integrated perspective: micro (the individual deviant action), meso (the work context and the organization) and macro (the organizational field and its institutional logics of operation).

Students will develop a solid understanding of the organizational, economic, historical and political circumstances that facilitate these crimes, and will have a general knowledge of the most common types of organizational deviance and business crimes in order to develop a deeper understanding of current events. This knowledge will be used to develop a theory of how these types of events inform today's political economy.

By the end of the course, students will have acquired:

- the knowledge to develop processes and methods for analyzing organizational deviance and corporate crime;
- the knowledge of the theoretical methodological coordinates of analysis for diagnosing organizational problems;
- the ability to understand and neutralize the processes of constructing organizational deviance;
- the ability to carry out organizational analysis, including case reading and practical application;
- the ability to find, understand, use and critique secondary organizational literature.

#### Contents

Tools and concepts for in-depth analysis and critical understanding of the processes of organizational deviance and corporate crime and the organizational determinants that may promote their occurrence and recurrence.

## **Detailed program**

Modern and contemporary societies are founded on organizations. Their influence in our daily lives has grown over time and today they dominate our scenario, wielding enormous power, distributing countless benefits and in some cases generating negative consequences. All interests-economic, political, social and cultural-are pursued through organizations. Organizations can produce negative outcomes unintentionally (accidents, disasters) or intentionally (misconduct, malfeasance, corporate crime).

Starting from an organizations theory approach, the course analyzes crimes committed by companies and organizations. The focus is on the behavior of organizations in their operational network, rather than on the individuals who commit violations. The emphasis on the deviant and illegal actions of individuals produces an incomplete and poor account of corporate crimes. Therefore, the course aims to provide students with tools and concepts for in-depth analysis and critical understanding of the processes of organizational deviance and corporate crimes from an integrated perspective: micro (individual deviant action, individuals), meso (the work context, the organization) and macro (the organizational field and its institutional logics of operation).

Students will develop a general knowledge of the most common types of corporate crimes in order to develop a deeper understanding of current events and the logic of law enforcement. Some thematic focuses will be conducted during the course to develop with students simulations of activation of the concepts and tools studied, including through the analysis of teaching cases.

## **Prerequisites**

Sufficient knowledge of logic and general culture.

## **Teaching methods**

The Course consists of 56 hours, about 50% of which will be didactic delivery (lectures with use of slides, audio and video) and 50% with interactive teaching (exercises, subgroup work, presentation of case studies from which to develop individual and subgroup work, prepared and discussed during the course, etc.).

## **Assessment methods**

Attending and nonattending students will be assessed through a written test based on open-ended questions regarding the course topics and the materials indicated in the "Reference Texts." No intermediate tests are scheduled.

The objective of the learning assessment is to check the preparation on the examination program and the ability to reflect independently on the critical points of the program.

The evaluation criteria for the written test are:

1. ownership of language - appropriate use of terms;
2. accuracy in logical exposition of topics;
3. ability to construct connections between topics;
4. completeness of exposition in view of time constraints;
5. analytical ability in commenting on chosen study texts.
