### **Short description**

Conservation of value and its transmission: museums and archives. The museum institution in its complex articulation enables the conservation and communication of intangible heritage. Some of the business museums will be presented and seen in their daily functionality. Attention will be paid to ethnographic museums (Carolina Orsini), such as Mudec. While for archives, the Polo di Archivio Storico and the Archivio Storico della Psicologia of the University of Milan Bicocca will allow in-depth studies from the sacred to the cultural good (Aurelio Molaro).

Finally, an in-depth look at ethnographic research in urban and island contexts of the Mediterranean (Francesco Vietti).

The course will include the following lectures/seminars.

The entire didactic method of delivery is organised with face-to-face lectures (Didactics Erogative).

Dialogue lectures (including exercises and small laboratory activities) will be used to stimulate a critical approach to the discipline and reflection on the experiences presented.

The course involves the completion of a dissertation at the end of the module by PhD students relating to certain topics presented in the lectures, with particular reference to the personal research question. The paper is assessed by the module lecturers as a whole and may or may not be approved.

#### Activities:

#### Conservation of cultural heritage: historical and critical aspects (AURELIO MOLARO)

Preserving the Sacred - The Roman Age - Monastic Culture and Libraries - The norms of protection in the modern age - The wars of religion - Revolutionary France - United Italy - The cult of monuments - The 20th Century: from monument to cultural heritage - A case study: Historical Archive of Italian Psychology of the University of Milan-Bicocca.

# Practices of conservation and valorisation of tangible and intangible ethnographic heritage today. The case of the Museo delle Culture in Milan (CAROLINA ORSINI)

Through a visit to the museum, the collections in storage and the archives, we will reflect on the most topical issues in the museography of ethnographic heritage, exemplifying museum strategies and practices adopted to address issues such as the sustainability of museums today, and the relationship with the public and stakeholders. It will also reflect on the importance of heritage biography, issues of provenance and ethics of collecting.

#### Anna Scudellari – Brand Heritage Strategist (FRANCA ZUCCOLI)

The speaker, replete with a long experience as the director of a major business museum, is currently engaged in intensive consultancy work for the enhancement of museum heritage. Her talk is aimed at presenting all the issues related to the management of assets kept by institutions and their communication. The second part of the day will be devoted to a visit to a Milanese business museum.

# Mobility and heritage. Ethnographic research and application experiences in urban and rural Mediterranean contexts (FRANCESCO VIETTI)

Although they are often represented in public discourse as a "dissonant" element with respect to the nexus of community, culture and territory, migration plays an important role in heritage processes. In this seminar we will examine various ethnographic researches conducted in Mediterranean island contexts

that show how cultural diversity has been a powerful factor in the transformation of intangible heritage. We will then look at some applied anthropology projects that in urban settings have promoted an intercultural reading of heritage as a factor of social cohesion through the active involvement of migrants and refugees in responsible tourism and global citizenship education.

# Participating and sharing. Heritage knowledge and practices in the Trasimeno area. Research in progress (DANIELE PARBUONO)

Starting from the contemporary scholarly debate and the main normative references on the subject, some concrete cases of "work" on intangible cultural heritage will be examined, problematizing the relationship between patrimonial action, cultural policies and the construction of locality.
