# From Gutenberg to Google: archiving and editing in a digital ecosystem

## **Module description**

What is philology? What are its tools and protocols? And how have these changed over time, crossing different technological environments, from the manuscript to the printed book to the online digital edition, and becoming part of the digital humanities kit? Starting from these fundamental questions, the module intends to discuss case studies that allow us to highlight the methodological constants inherent in the archiving and critical care of (hyper)textual data, seen in a diachronic perspective from antiquity to the contemporary age.

The meetings will be aimed at encouraging reflection on two substantial points:

- 1. How to archive data in the dual analog and digital perspective?
- 2. How to create an information hierarchy within (hyper)texts stratified at a diachronic and synchronic level?

To achieve this goal, students will be guided to critically examine different practices of graphic representation of texts and knowledge preservation in the field of human sciences.

#### Learning goals

- Providing knowledge of some elements that characterize the philological and archival discipline, within the
  context of digital humanities, training in a depth of gaze that goes from antiquity to the contemporary age
  through the discussion of case studies that will be critically examined and verified
- 2. Promoting reflection on the possibility of planning philologically informed research in the field of human sciences; investigate the plurality of theoretical and methodological possibilities within the philological paradigm

#### **General goal**

Developing a critical positioning with respect to the different practices of graphic representation of texts and conservation of knowledge in the field of human sciences

#### Specific skills and competences

- 1. Knowing how to identify the elements that outline a philological paradigm within research in the field of human sciences
- 2. Knowing how to discuss and analyze some possible options for philologically oriented research hypotheses that range diachronically from antiquity to the contemporary age
- 3. Knowing how to position yourself critically with respect to the case studies described in the course.
- 4. Knowing how to define the course topics on a research object of one's own interest.
