## Administrative Law - A-L

## Learning objectives

1. Knowledge and understanding

Provide basic knowledge of Public Administration broadly meant, its organization and activities.

2. Applying knowledge and understanding

Develop juridical approaches and methodologies for the analysis of administrative law, even through cases.

#### 3. Making judgements

Critically evaluate acts and behavior of the public administration, making independent judgments about the legitimacy and effectiveness of administrative action.

Develop a critical approach useful for identifying legally grounded solutions to problems of administrative law.

- 4. Communication skills
  - Present clearly, both orally and in writing, and interact appropriately on administrative law issues.
- 5. Learning skills

Develop the skills necessary to update his or her knowledge independently and approach advanced studies in the field of public and administrative law.

#### **Contents**

The course aims to study the administrative authorities, their proceedings and activities. Particular attention will be dedicated to the analysis of the existing problems due to the deep and on going transformations in administrative law.

## **Detailed program**

Public administration: rights and duties;

Administrative procedure;

Public administration power and subjective legal positions;

Administrative act and administrative measure;

Liability in public administration;

Notes on administrative justice: administrative and jurisdictional protection.

## **Prerequisites**

None specifically, even if as a 3rd year studente it is required appropriate capacity in learning, writing and speaking, together with a general legal knowledge.

## **Teaching methods**

The lessons will take place "in class". Streaming could be used in exceptionally events.

Considering working students, some lessons on fundamental topics could be recorded and uploaded on e-learning and some lessons could be in streaming not in conventional time table but late in the evening (6.30-8.30 p.m.) There could be seminars on specific subjects hosting professors of other Universities.

In class pwp presentation will be uploaed on the e-learning platform.

#### **Assessment methods**

Oral exam in which knowledge, understanding and expository skills will be assessed. There may be one or more optional written test for students in class.
