Learning objectives

The course aims to provide a systematic understanding of the phenomenon of international organizations, by examining the legal nature of international organizations and state unions, as well as the legal issues concerning their functioning, powers, and relevance within the international legal system.

The learning objectives are as follows:

a) Knowledge and understanding

Students will acquire a critical and in-depth knowledge of the legal nature of international organizations, their institutional structure, functions, and the normative sources governing their activities. They will also understand the differences between various forms of international organizations and state unions, and the role these entities play in global governance.

b) Applying knowledge and understanding

Students will be able to identify and interpret relevant legal rules and documents related to the operation of international organizations. They will develop the ability to analyze real cases concerning the legal acts or activities of such organizations and resolve legal questions regarding their powers, responsibilities, and immunities.

c) Making judgments

The course fosters critical and independent thinking on the role of international organizations in contemporary international law, encouraging students to assess their impact on the balance between state sovereignty and international cooperation, as well as the legitimacy of their interventions in various global contexts.

d) Communication skills

Students will develop the ability to present legal knowledge on international organizations in a clear and coherent manner, using the appropriate technical and legal terminology specific to international institutional law.

e) Learning skills

Students will strengthen their capacity for independent learning and in-depth study of the discipline, including through the use of primary sources and official documents of international organizations, in preparation for further academic or professional paths in international law and international relations.

The course addresses the following key topics:

The legal nature of international organizations and unions of states

Types of international organizations, with particular focus on universal organizations (e.g., United Nations and its specialized agencies) and regional organizations (e.g., African Union, Organization of American States, Council of Europe)

The legal personality of international organizations

Constitutive acts and internal structure of organizations

Organs, powers, and functions

Internal legal systems and immunities

Legal responsibility of international organizations

The relationship between international organizations and the legal systems of member states

Types of international organizations: universal, regional, technical, intergovernmental

Legal nature and personality of international organizations

Founding instruments and fundamental principles

Prerequisites

Students are expected to have a solid background in the fundamentals of international law, particularly concerning:

International legal personality

Sources of international law (treaties, custom, general principles)

State responsibility

International dispute settlement

Teaching methods

The course is delivered through interactive lectures, combining traditional teaching with active student engagement.

Legal principles and rules governing international organizations will be critically examined through discussion of official documents, case law, and other materials distributed in class or available on the course e-learning platform.

Active student participation is encouraged to promote independent analysis and deeper understanding.

Assessment methods

The exam is oral. No written midterm assessments are included. The exam consists of two general questions covering topics discussed in class and included in the recommended readings. In order to pass the exam, students must provide satisfactory answers to both questions, demonstrating:

A sound theoretical understanding of the subject matter

The ability to conduct legal analysis and argumentation

Proper command of technical legal terminology
