Law of Religions

Learning objectives

The course provides an overview of the legal challenges that religious rights pose in contemporary society. Particular attention will be paid to family law and the institution of marriage.

Contents

When delving into the realm of law, one encounters a captivating array of perspectives that extend far beyond the mere confines of the state. Religions, in fact, boast internal legal systems that intricately regulate various aspects of believers' lives. These systems are designed to provide guidance and enforce discipline over specific behaviors within religious communities. By immersing ourselves in these three distinct legal frameworks, we embark on a journey through diverse religious traditions, meticulously examining the norms, practices, and social and cultural implications associated with this institution.

Through this comparative approach, participants will not only attain a deeper understanding of matrimonial law within the "religions of the book" but also gain a broader perspective on the varying conceptions of marriage, family, and community within the global social fabric.
